Discussions:

- 1. MIF Application (Baltej Kooner)
 - a. Would like to start a cross training program to help guide and motivate students in pharmacy who have not had the opportunity to have one-on-one fitness training
 - b. Exercise and form into a training program comprised of 5 randomly drawn students who sign up
 - c. Group provides each other with motivation incorporating fitness into their daily lives
 - d. 4 training sessions split into availability
 - e. \$200 MIF, \$175 will go towards 5 gym membership at the ARC
 - i. \$25 will go towards coffee debrief at the end for improvement
 - f. Survey will go out to people
 - i. Randomly selected
 - g. Mainly for people who would like more support working out
 - h. Liability will be under the waiver they sign at the ARC
 - i. Goal of the project is to help individuals who do not have experience working out, to continue helping that individual working out in the future
- 2. MIF Application (Jamie Park and Elisa Colasurdo)
 - a. Recruited pharmacists from unique backgrounds in pharmacy last term, provided interview questions for different pharmacists
 - b. Shirin Abadi has a blog post up already, another post to be scheduled January 30
 - c. Funding would be in the form of gift cards as a thank you gift for interviews that take place in person
 - i. Some interviews are via email or over the phone; thank you gift is harder to give to the pharmacist
 - ii. Requesting ~\$60
 - d. Gathering speakers to connect with various backgrounds of pharmacy to try to gauge the student interest of what they would like to pursue after graduation
