2021 PhUS Elections Electoral Procedures

The 2021 PhUS Elections Committee is composed of Parsa Shahbazi-Amin (PhUS President) and Jessica Jiang (PhUS VP Finance). The Elections Committee will act as an impartial, autonomous body to impose the Electoral Procedures as outlined by the PhUS constitution and the AMS Code. All questions regarding elections should be directed to the Elections Committee at president@ubcphus.org.

1. Nomination forms with the names and student numbers of five E2P PharmD students who are nominating you must be received by the Elections Committee by email prior to March 15th, 2021 at 6:00 PM. Please send the completed nomination forms to president@ubcphus.org
2. All candidates are required to attend an **All Candidates Meeting on March 15th, 2021 at 7:00 PM**. If you are unable to attend the All Candidates Meeting, please send a representative to attend on your behalf or send an email to president@ubcphus.org prior to 12:00 PM on March 15th, 2021.
3. If a position is vacant at the All Candidates Meeting, a candidate may switch into the vacant position. If no positions are vacant, no candidate may choose to switch into another position.
4. Candidates must refrain from campaigning outside of the **designated campaigning period of March 20th to 26th**.
5. Candidates and their endorsers are forbidden from giving speeches or Q&A info sessions during faculty, pharmacy association, club, fraternity, and undergraduate society meetings or events. In the event that candidates are invited to give a Q&A session by the aforementioned organizations, all candidates must be afforded the same opportunity. The Elections Committee should also be notified immediately.
6. Any current PhUS General Council member running for a position should refrain from making class announcements on behalf of PhUS during the campaigning period. This includes class announcements over the UBC Pharmacy Class of 20XX or UBC Pharmacy Hub Facebook pages .
7. Candidates are not permitted any financial expenditure and/or monetary items on their campaign, nor are other individuals permitted to do so on their behalf, whether solicited or not. In the event of ambiguity as to what constitutes financial expenditure/monetary items, candidates must consult with the Elections Committee for clarification.
8. Any endorsements must be received along with the candidate's headshot, statement, and campaign video by email to the Elections Officer by **March 19th at 7:00 PM**. The endorsement must include a list of individuals providing endorsement for your candidacy. Endorsements not included in the submitted list should be retracted by the undeclared endorser. No current member of the Executive Council shall partake in endorsing another



candidate in this election, in any form. Candidates are neither permitted to seek faculty endorsement, nor permitted to seek endorsement from external organizations.

9. Candidates may not endorse other candidates in this election (i.e., “slates”).
10. Campaigning materials will be limited to an electronic format. The creation of Facebook events is prohibited, as is posting campaign materials directly on the class year Facebook groups.
11. Campaign materials must not include the PhUS logo.
12. Each candidate is to prepare a campaign speech in the form of a video, which will be made available for viewing through various platforms to all UBC Pharmacy students. The video must be limited to one (1) minute in length. The video will be made available for viewing on various platforms. For further information, please reach out to one of the aforementioned Elections Officers.
13. Negative campaign tactics towards other candidates or towards any members of the Elections Committee are forbidden, and may result in consequences at the discretion of the Elections Committee.
14. Finalized elections dates and times will be announced at the All Candidates Meeting. Currently, the election dates are scheduled from March 22nd - 26th, 2021.
15. Votes will be tabulated electronically and released to the respective candidates within 48 hours of polls closing. Winning candidates will have the opportunity to accept or reject the offered position at the time of disclosure. A candidate may not contest the election results, the winner is defined as the candidate who has allocated the greatest number of votes for their respective position. Final election results will be released and made available to the public once all winning candidates have agreed to the results.
16. In the event a dispute arises concerning election procedures or regulations (not the results), candidates must state their dispute within 48 hours of the alleged violation. The dispute will be addressed at the discretion of the Elections Committee. Any valid disputes and subsequent disciplinary action will be documented and made public to the student body.
