1. President

- a) Just Desserts Nomination
 - Please nominate one student or faculty member that you feel helped shape PhUS into what it is today https://forms.gle/zbjBMbkqLzfAxRkB9
 - Deadline is this Thursday at AGM!
- b) Proposed Constitution Changes (open discussion)
 - Quorum cut-off change from 15% of Members (~130 students) to 30 Members at AGM
 - Wanted to discuss this with the larger PhUS Council after finding no objections to the change at the Constitution Review Committee meeting last week

Context:

- This change would allow future years to regularly update the Constitution to reflect actual practice; better transparency and clarity of roles within PhUS
 - Example: AVPs have been part of PhUS since COVID started (2020) and the Constitution has not been updated accordingly
- 15% pharmacy students at AGM is an impossible standard that has been artificially imposed. It originates from the 15% quorum required to become a constituency under the AMS → no rule imposed on constituencies that PhUS AGM quorum = 15%
 - Example: EUS is 1/20th of Active Members at AGM
- c) Advisory Group for Inpatient Experiential Education
 - Still seeking a member from PhUS Council in PY2 or PY3 to join
