a. TILAK Endowment Fund

TILAK Endowment: what is this intended for?

- "Equipment and/or software to provide and/or upgrade information technology for the undergraduate pharmacy student body."
 - Key here would be 'student body' expenditures should not be of benefit to a small group of members or individuals.
 - Should be spent on something accessible to many/all.

How much is currently available?

- \$12,460.04 available to be spent in *total*; (untouched for eight years!)
- Produces ~\$1,201.04 per year (based on market)
- Canva Pro Teams funding is approved
 - Need to submit paperwork along with invoice

<u>Proposal of Accounts</u>- Subscription managed by VP Comm.

- 1) PhUS Communications Account (incl. year reps)
- 2) PhUS Social and Sponsorship Account (Sponsorship)
- 3) PhUS Clubs Account (Internal)
